Investment Policy

The Balkerne Asset Management UK Mixed ISA investment policy is to achieve the investment objective by investing principally, but not exclusively, in UK blue-chip equities within the FTSE-350 Index and fixed-interest/bond investments and, as appropriate, OEICs, Unit Trusts, Investment Trusts and other collective investments and as appropriate, other securities.

The Balkerne Asset Management UK Mixed ISA is an actively managed portfolio of between 25 and 35 holdings with a nominal cash holding.

Valuations & Reporting

Half-yearly valuations are issued as at 5th April and 5th October of each year. Included with the valuation is a schedule of income received for the period and a dealing summary.
