The Balkerne Asset Management UK Mixed MFS investment policy is to achieve the investment objective by investing principally, but not exclusively, in OEICs, Unit Trusts, Investment Trusts and other collective investments and, as appropriate, UK blue-chip equities within the FTSE-350 Index and fixed-interest/bond investments.

The Balkerne Asset Management UK Mixed MFS is an actively managed portfolio of between 10 and 20 holdings with a nominal cash holding.

Valuations & Reporting

Half-yearly valuations are issued as at 5th April and 5th October of each year. Included with the valuation is a schedule of income received for the period.
