Investment Policy

The Balkerne Asset Management UK Stockmarket MSS portfolio investment policy is to achieve the investment objective by investing principally, but not exclusively, in UK blue-chip equities within the FTSE-350 Index, and as appropriate, fixed-interest/bond investments, OEICs, Unit Trusts, Investment Trusts, other collective investments and other securities.

The Balkerne Asset Management UK Stockmarket MSS portfolio is an actively managed portfolio of between 20 to 30 holdings, with a nominal cash holding.

Valuations & Reporting
