Lead Manager's Commentary as at 31.03.25

The Income MFS returned -1.5% over the first quarter of 2025 and -0.1% over the last 12 months.

Performance was driven by both asset allocation and stock selection. We hold an overweighting in fixed-interest/ corporate bonds. Our best performing funds over the quarter being Jupiter Strategic Bond Fund and Royal London Corporate Bond Fund.

The Income MFS holds a neutral weighting to equities. Outperformers in the quarter included Scottish Mortgage Trust, Blackrock World Mining Trust, Schroder Oriental Income Trust and EdenTree Responsible & Sustainable UK Equity Opps Fund. Underperformers included Edinburgh Worldwide Trust and Artemis US Smaller Companies Fund.

We are overweight alternative assets. Our best performing commercial property holding was Tritax Big Box REIT and our best performing alternative was Supermarket Income REIT.

Two new holdings were established in the quarter Artemis US Smaller Companies Fund and JPMorgan American Trust. No positions were exited in the quarter.

The Income MFS is positioned to benefit from the recovery in the western world and take advantage of lower interest rates. We favour income producing assets, with some inflation protection and a balanced exposure to UK & International equities and corporate debt, whilst retaining a minimal weighting to direct sovereign debt.
